

The Board of Public Works would like to request the following transfer of funds:

From: #63 Grants and Subsidies \$12,500

To : #264 Services Contractual \$12,500

We are requesting this transfer to provide funds for professional engineering services for preliminary engineering concepts and preliminary cost estimates to correct surface storm drainage problems in Watershed Area A.

The funds were appropriated for payment to Indiana University, for the amount due on the Incinerator Account for 1975. Our understanding is that other arrangements have been made with Indiana University for settling the Incinerator Account claims and that this money is available for other projects.
