

APPROPRIATION ORDINANCE 75-11

AN ORDINANCE APPROPRIATING FROM THE COMMUNITY DEVELOPMENT BLOCK GRANT FUND

WHEREAS, the City of Bloomington, Indiana is entitled to the sum of \$1,004,000.00 as a Non-Metropolitan Entitlement City (Sec. 106) under the provisions of Title I of the Housing and Community Development Act of 1974 (Public Law 93-383); and,

WHEREAS, the City of Bloomington, Indiana has completed grant application B-75-HN-18-0002 on April 11, 1975, and,

WHEREAS, Grant No. B-75-HN-18-0002 was approved for funding as submitted and proposed on May 20, 1975, and,

WHEREAS, the City of Bloomington, Indiana has reached a finding of no significant impact in the Environment, and, said finding has been published and no contradictory finds or comments have been received, and, therefore, said finding and said Publication have been affirmed completing the City of Bloomington's obligation under 24 CFR S 58.16, Environmental Regulations for Title I Programming.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION I. That there be, and hereby is appropriated from the Community Development Block Grant Fund of said City, the following sums:






SECTION II. THIS ORDINANCE shall be in full force and effect from and after its passage by the Common Council and its approval by the Mayor.

PASSED and ADOPTED by the Common Council of the City of Bloomington, Indiana this 6 day of November, 1975.


