

ORDINANCE 74-27

AN ORDINANCE CONCERNING THE ANNEXATION
OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana is adjacent to the real estate described herein,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

Parts of Sections 35 and 36, Township 9 North, Range 1 West, in Monroe County, Indiana, more specifically described as:

Starting at a point, said point being the Northeast corner of Morningside Drive and Smith Road, running thence West along the North right-of-way of Morningside Drive to the Southeast corner of Lot 101, Parkridge Addition, a platted addition recorded at Plat Book 4, page 93 in the Monroe County Recorder's Office, Bloomington, Indiana, running thence North along the East lot lines of lots 101 and 108 of said Parkridge addition and lots 109, 110 and 111 of Parkridge North Addition, a platted addition recorded at Plat Book 4, page 97, in the Monroe County Recorder's Office, Bloomington, Indiana to the Northeast corner of said Lot 111, said point being on the South right-of-way of the Illinois Central Gulf Railroad, running thence East along the South right-of-way line of said Illinois Central Gulf Railroad to the East right-of-way line of Smith Road, running thence South along the East right-of-way line of Smith Road to the point of beginning.

SECTION 2. Be it further ordained, that the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.
