

ORDINANCE NO. 74-30

AN ORDINANCE CONCERNING THE ANNEXATION
OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana,
is adjacent to the real estate described herein,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF
THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the
same is, hereby annexed to and declared a part of the City of
Bloomington, Indiana, to-wit:

A part of Sections 35 and 36, Township 9 North,
Range 1 West, Monroe County, Indiana, described
as follows, to-wit: Beginning at a point, said
point being the intersection of the South right
of way line of the Illinois Central Gulf Rail-
road and the East right of way line of Smith
road, running thence in a Northeasterly direction
along the South right of way line of said Illinois
Central Gulf Railroad to a point, said point being
on the South right of way line of said Illinois
Central Gulf Railroad and directly East of the
Southeast corner of Lot 61, Eastern Heights, 3rd
Addition, a platted addition recorded in Plat
Book 5, page 14 in the Monroe County Recorder's
Office, Bloomington, Indiana, running thence to
the Southeast corner of said Lot 61, running thence
in a generally westerly direction along the South
Eastern boundary of Eastern Heights, 3rd Addition
and Eastern Heights, 2nd Addition more specifically
described as: North 55 degrees 8 minutes West 318
feet, thence South 33 degrees West 130 feet, thence
North 56 degrees 24 minutes West 330 feet, thence
South 13 degrees 4 minutes East, 199.8 feet, thence
South 82 degrees 57 minutes West 238 feet, thence
West 126 feet, thence South 64 degrees 45 minutes
West 120 feet, running thence South 63 degrees 12
minutes West 235.5 feet, more or less and to the
East right of way line of Smith Road, running thence
North along the East right of way line of Smith
Road to the intersection of the East right of way
line of Smith Road and the south right of way line
of Indiana State Highway 45, thence Southeast along
the South right of way of Indiana State Highway 45
to the intersection of the South right of way of
Indiana State Highway 45 and the West right of way
line of Smith road, running thence South along the
West right of way line of Smith Road to the inter-
section of the West right of way line of Smith road
and the South right of way line of the Illinois
Central Gulf Railroad, running thence East along
the South right of way line of the Illinois Central
Gulf Railroad to the point of beginning.

The above description describes that real estate
lying East of Smith Road, North of the Illinois
Central Gulf Railroad, and South and East

of Eastern Heights Subdivision, including among other properties Meadow Park Apartments.

SECTION 2. Be it further ordained, that the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.
