

ORDINANCE NO. 74-45

AN ORDINANCE CONCERNING THE ANNEXATION
OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana, is adjacent to the real estate described herein,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

A part of the Northeast quarter of Section 29, Township 9 North, Range 1 West, in Monroe County, Indiana, further described as follows: Beginning at a point 376.06 feet North of the Southeast corner of said Northeast quarter and in the centerline of Kinser Pike; thence North on the centerline of Kinser Pike for 1769.00 feet; thence Northwesterly on the centerline of Kinser Pike for 1013 feet and to the Northwest corner of Cascades Addition; thence following the boundary of Cascade Addition the following directions and dimensions:

South for 413 feet,
West for 419 feet,
South for 572 feet,
East for 8.25 feet,

South for 780.2 feet and to the North boundary of the Bloomington Metropolitan School property; thence West along the North boundary of the said school property 476.53 feet to the Northwest corner of the said school property; thence South along the West boundary of the school property to the North right-of-way of the State Road 46 By-Pass; thence along the said right-of-way the following directions and dimensions:
-South 87 degrees 50 minutes East for 341.48 feet,
North 86 degrees 46 minutes 37 seconds East for 403.79 feet; Southeasterly along a curve to the right for 496.01 feet, said curve having a radius of 23,068.31 feet and being subtended by a chord bearing South 86 degrees 20 minutes 48 seconds East and a length of 496.00 feet; South 85 degrees 50 minutes 00 seconds East for 318.68 feet; North 49 degrees 27 minutes 54 seconds East for 63.58 feet; North 03 degrees 47 minutes 51 seconds East for 112.43 feet; South 89 degrees 22 minutes 42 seconds East for 57.53 feet and to the point of beginning.

Above description includes land in, and adjacent to, Cascades Addition.

SECTION 2. Be it further ordained, that the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.
