

ORDINANCE NO. 74-55

AN ORDINANCE AMENDING BLOOMINGTON MUNICIPAL CODE  
CHAPTER 2.76, ENTITLED "DEPARTMENT OF TRANSPORTATION"

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE  
CITY OF BLOOMINGTON, INDIANA:

SECTION 1. Bloomington Municipal Code Section 2.76.010  
is hereby amended to read as follows:

2.76.010 Created. There shall be and hereby  
is established a Department of Public Transit  
within the Administration of the corporate  
City of Bloomington, Indiana, which Department  
shall be under the management and control of  
the Board of Public Works.

SECTION 2. Bloomington Municipal Code Section 2.76.020  
shall read as follows:

2.76.020 Duties. The scope of the duties of  
the Department of Public Transit shall include  
and be limited to the orderly maintenance and  
administration of the public transportation  
system of the City of Bloomington.

SECTION 3. Bloomington Municipal Code Section 2.76.030  
is hereby amended to read as follows:

2.76.030 Governed. The Department shall be  
governed by administrative regulations  
established by the Board of Public Works.

SECTION 4. Bloomington Municipal Code Section 2.76.040  
is hereby amended to read as follows:

2.76.040 Head-Title-Appointed. The head of  
the Public Transit Department shall be designated  
Director of Transportation and shall be appointed  
by the mayor with the approval of the Board  
of Public Works.

SECTION 5. Bloomington Municipal Code Section 2.76.050  
shall read as follows:

2.76.050 Functions. The Department of Public  
Transit shall function continuously from January  
1, 1973 and shall perform such functions as are  
necessary for the continued maintenance of a  
public transportation system within the intent  
of this chapter.

SECTION 6. That this ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.
