ORDINANCE NO. 74-64

AN ORDINANCE TO AMEND THE BLOOMINGTON ZONING MAPS, DATED JUNE 22, 1973

WHEREAS, the Common Council of the City of Bloomington, Indiana passed a zoning ordinance amendment and adopted new incorporated zoning maps on June 21, 1973, and

WHEREAS, said zoning ordinance and maps are now incorporated in the "Bloomington Municipal Code" as Title 20 of said Code, and

WHEREAS, the City Plan Commission has recommended said Bloomington Zoning Maps be amended by the rezoning of certain property. As specified in zoning case ZO-33-74.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174 OF THE 1947 ACTS OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA AND ALL ACTS SUPPLEMENTARY AND AMENDATORY THERETO:

SECTION 1. That the incorporated map number 7, of June 22, 1973, be amended to rezone the following described land in the City of Bloomington, Monroe County, Indiana from its present RM-Residential Medium density zone classification to a RS- Residential Single Family zone; to-wit:

A part of the Northwest quarter of Section Three (3), Township eight (8) North Range One (1) West, described as follows: Lots sixty-five (65) and sixty-six (66) in Campus Place Addition; Lots one (1) through nine (9) and Lots Twenty-eight (28) through forty-seven (47) in Hunter Park Addition; Lots one (1) through six (6) in Kirkwood Heights Addition. Also, that portion of Lot sixteen (16) in Kirkwood Heights and that portion of original Out Lot one hundred twenty-seven (127) which is presently zoned RM- Residential Medium Density.

SECTION 2. That this ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
