ORDINANCE NO. 74-68

AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana, is adjacent to the real estate described herein,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

> A part of the Southeast quarter of Section 34, Township 9 North, Range 1 West, in Monroe County, Indiana, bounded and described as follows, to-wit: Commencing at a point on the east line of said Section 34, Township 9 North, Range 1 West, 180 feet north of the southeast corner of said Section 34, running thence north along the east line of said Section a distance of 150 feet, running thence west 62 feet, running thence south parallel with the east line thereof 150 feet, running thence east 62 feet and to the place of beginning.

> A part of the southeast quarter of Section 34, Township 9 North, Range 1 West, in Monroe County, Indiana, bounded and described as follows, to-wit: Beginning at a point 62 feet west of the southeast corner of the southeast quarter of Section 34, Township 9 North, Range 1 West, thence running north 118 feet and 6 inches, thence running east 4 feet, thence running north 43 feet and 3 inches, thence running west 4 feet, thence running north 18 feet and 3 inches, thence running west 136 feet, thence running south 180 feet and to the south line of said Section 34, Township 9 North, Range 1 West, thence running east over and along the south line of said Section 34, a distance of 136 feet and to the place of beginning.

A part of the southeast quarter of Section 34, Township 9 North, Range 1 West, in Monroe County, Indiana, bounded and described as follows, to-wit: Commencing at a point 180 feet north and 62 feet west of the southeast corner of the southeast quarter of Section 34, Township 9 North, Range 1 West, running thence north parallel with the east line of said southeast quarter a distance of 150 feet, running thence west 136 feet, running thence south parallel with the east line thereof 150 feet, running thence east 136 feet and to the place of beginning.

Also, beginning at a point 20 rods and 5 feet, more or less, north and 62 feet west of the southeast corner of Section 34, Township 9 North, Range 1 West, said beginning point being on the south property line of Edward Row as shown by the recorded plat of Hillsdale Addition to the City of Bloomington, Indiana, running thence west along the south property line of Edward Row 136 feet, thence south 5 feet, more orless, to a point 20 rods north of the south line of the southeast quarter of said Section 34, running thence east 136 feet, thence north 5 feet, more or less, to the point of beginning.

The above description describes property owned by Buck Lemon Furniture Store of Bedford, Inc., located on East Third Street.

SECTION 2. Be it further ordained, that the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.
