

ORDINANCE NO. 74-98

AN ORDINANCE CONCERNING THE ANNEXATION OF  
ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana,  
is adjacent to the real estate described herein,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF  
THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the  
same is, hereby annexed to and declared a part of the City of  
Bloomington, Indiana, to-wit:

A part of the Southwest quarter and the North-  
west quarter of Section 28, Township 9 North,  
Range 1 West, Monroe County, Indiana, described  
as follows: Beginning at a point on the North  
right-of-way of State Highway #46 By-Pass  
1253.8 feet West of the Northeast corner of the  
Southwest quarter of Section 28; running thence  
South to the North line of the Southwest quarter  
of Section 28; running thence South 271 feet,  
more or less, thence East 461.8 feet; thence  
South 279 feet; thence East 273.5 feet; thence  
North 250 feet; thence East 150 feet; thence  
North 300 feet and to a point on the North line  
of the Southwest quarter of section 28 368.5  
feet West of the Northeast corner thereof;  
thence North to the North right-of-way of State  
Highway #46 By-Pass; thence West along said  
right-of-way to the point of beginning.

The above description describes properties  
lying West of Dunn Street, East of Highway  
#37, North of Walnut Knolls Apartments, and  
South of State Highway #46 By-Pass.

SECTION 2. Be it further ordained, that the boundaries  
of the City of Bloomington shall be, and the same are, hereby  
declared to be extended so as to include all of the real estate  
hereinabove described as a part of the City of Bloomington,  
Indiana.

SECTION 3. This Ordinance shall be in full force and effect  
from and after its passage, promulgation, approval by the Mayor  
and publication in accordance with the law.


