

APPROPRIATION ORDINANCE NO. 74-2

AN ORDINANCE SPECIALLY APPROPRIATING FROM THE SPECIAL FUNDS, EXPENDITURES NOT OTHERWISE APPROPRIATED, OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, TO MEET THE EXTRAORDINARY EMERGENCIES FOUND TO EXIST IN THE VARIOUS DEPARTMENTS.

WHEREAS, certain extraordinary emergencies have developed since the adoption of the existing annual budget, so that it is now necessary to appropriate more money than was appropriated in the annual budget;

NOW, THEREFORE, TO MEET SUCH EXTRAORDINARY EMERGENCIES, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

Section I. That there be and hereby is appropriated from the Special Funds of said City, funds not otherwise appropriated, to meet the extraordinary emergencies found to exist for the expenditure of more money for the current year of 1974 than was set out in detail in the budget as finally adopted, and appropriations as finally made, the following sums:

Section II. Provided, however, that the City Controller shall not honor any claims against this appropriation nor disburse any of these appropriated funds until such time as satisfactory evidence is shown that the Kirkwood Area Merchants, property owners, professionals and all interested persons, either collectively as a group or individually, have made adequate financial assurances that a sum of not less than fifty thousand (\$50,000.00) dollars will be contributed by them to the Kirkwood Mall Project.

Section III. THIS ORDINANCE shall be in full force and effect from and after its passage by the Common Council and its approval by the Mayor.
