

ORDINANCE NO. 73-22

AN ORDINANCE CONCERNING THE ANNEXATION  
OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana, is adjacent to the real estate described herein,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

A part of the Northeast quarter of the Northwest quarter of Section 10, Township 8 North, Range 1 West, of the Second Principal Meridian, in Monroe County, Indiana, bounded and described as follows, to-wit: Beginning at a point 810 feet west of the Northeast corner of said quarter quarter and 20 feet South of the North boundary of said quarter quarter, said point also being described as a point on the south right-of-way of Hillside Drive at the Northwest corner of a subdivision of record, Beechwood Manors, running thence from said point of beginning South 2 degrees East a distance of 318 feet, thence running south 89 degrees West and parallel to the North boundary of the quarter quarter a distance of 200 feet, thence running North 2 degrees West a distance of 318 feet and to a point on the south right-of-way of Hillside Drive 20 feet South of the North boundary of the quarter quarter, thence running North 89 degrees East along and with said south right of way a distance of 200 feet and to the point of beginning, containing 1.47 acres more or less.

Said above described real estate is located at 1724 East Hillside.

SECTION 2. Be it further ordained, that the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.
