

ORDINANCE NO. 73- 30

AN ORDINANCE CONCERNING THE ANNEXATION
OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, The Boundary of the City of Bloomington, Indiana,
is adjacent to the real estate described herein,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF
THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the
same, is hereby annexed to and declared a part of the City of
Bloomington, Indiana, to-wit:

A part of Section 1, Township 8 North, Range 1
West, Monroe County, Indiana, described as follows:
Beginning at a point, said point being the inter-
section of the South right-of-way of Indiana State
Highway #46, and the East right-of-way of Indiana
State Highway #446, thence running South along
the East right-of-way of Indiana Highway #446 to
a point 1219 feet South of the Northeast corner of
the Northwest quarter of said Section 1, thence
running West to a point, said point being the
Southwest corner of the Knightridge Manor property
as recorded in Deed Book 166, page 448, in the
Monroe County, Indiana, Recorder's Office, thence
running North to a point, said point being the
Northwest corner of the Clark-Owens Oil Company
property as recorded in Deed Book 200, page 395, in
the Monroe County, Indiana, Recorder's Office,
thence running East along the South right-of-way of
Indiana State Highway #46 to the point of beginning.

The above described real estate comprises that
land lying south of Highway #46 to and including
Knightridge Manor Apartments.

SECTION 2. Be it further ordained, that the boundaries of
the City of Bloomington shall be, and the same are, hereby de-
clared to be extended so as to include all of the real estate
hereinabove described as a part of the City of Bloomington,
Indiana.

SECTION 3. This ordinance shall be in full force and effect
from and after its passage, promulgation, approval by the Mayor
and publication in accordance with the law.
