## ORDINANCE NO. 73- 4/

AN ORDINANCE AMENDING THE CITY CODE OF BLOOMINGTON BY ADDING THERETO SECTION

2.04.570 Ordinances--First Reading

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. The City Code of Bloomington is hereby amended to read as follows:

2.04.570 Ordinances--First Reading. An ordinance shall be read a first time by the clerk when the proper order of business is reached during the session of the council; provided, that Section 2.04.560 is complied with or waived. By the unanimous consent of all members of the council present at the meeting at which an ordinance is introduced, the reading of such ordinance in its entirety by the clerk may be waived and in the place and stead of such reading, the clerk shall read such ordinance by title only and shall within twenty-four hours deposit for the purpose of public examination copies of the ordinance at the following places:

- (a) Two copies in the office of the mayor;
- (b) Two copies in the office of the city clerk;
- (c) Three copies in the Monroe County public library;
- (d) Three copies in the office of the chamber of commerce of the city of Bloomington; and such copies shall be available for examination by the public, provided, however, when the time for such deposit of such ordinances in the places indicated falls on Saturday, Sunday or a legal holiday such deposit may be made on the first working day immediately following such Saturday, Sunday or legal holiday. In the event such ordinance be read, the

first reading of such ordinance shall be in its entirety, and shall be for information only. An ordinance may not be debated or amended on its first reading or introduction, but shall normally be referred to an appropriate committee for consideration and recommendation.

SECTION 2. That this ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.
