## ORDINANCE OF THE CITY OF BLOOMINGTON, COUNTY OF MONROE, STATE OF INDIANA

ORDINANCE NO. 73-48

AN ORDINANCE TO AMEND MAP NO. 1 OF THE INCORPORATED ZONING MAPS OF TITLE 20 OF THE BLOOMINGTON MUNICIPAL CODE

WHEREAS, The Common Council of the City of Bloomington, Indiana passed a zoning ordinance amendment and adopted incorporated zoning maps on June 21, 1973, and

WHEREAS, said zoning ordinance amendment and incorporated zoning maps are now included in the "Bloomington Municipal Code" as Title 20 of said Code, and

WHEREAS, the City Plan Commission has recommended that said zoning map No. 1 be amended by the rezoning of certain property.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174 OF THE 1947 ACTS, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA:

SECTION i. That Map No. If of the incorporated maps of Title 20 of the Bloomington Municipal Code, be amended to change the designation of the following described land in Monroe County, Indiana from its present RS-Single Dwelling Residential District to an RS-PUD-Single Dwelling Residential Planned Unit Development zoning classification, to-wit:

A part of Section 18, Township 9 North, Range 1
West, Monroe County, Indiana described as follows:
Beginning at a point on the South line of the said
section, thence West, over and along the said South
line, for a distance of 2312.7 feet, thence North,
over and along the West line of the said section, for
a distance of 2628.2 feet, thence East for a distance of 2172.0
feet, thence North for a distance of 1317.5 feet, thence
East for a distance of 337.5 feet, and to the center line
of Maple Grove Road, thence Southeasterly, over and along
the center line of Maple Grove Road, for a distance of
2501.3 feet, and to the intersection of the North line of
Lot Number 10 in Upper Flanders as platted with the said
center line, thence South 84 degrees 04 minutes West, over
and along the North line of Lot Numbers 10, 11, 12, 13 and 14
and its extension, for a distance of 720.0 feet, thence
South 24 degrees 39 minutes 50 seconds West for a distance
of 988.3 feet, thence North 74 degrees 25 minutes West for
a distance of 200.00 feet, thence South 0 degrees 55 minutes
08 seconds East for a distance of 532.55 feet, thence
North 85 degrees 28 minutes 30 seconds East for a distance
of 200.00 feet, thence South 0 degrees 04 minutes West for
a distance of 247.20 feet, and to the place of beginning.
Containing 202.97 acres, more or less.

Excepting therefrom the following described property:

- 1. A part of the West half of the Southeast quarter and a part of the West half of the Northeast quarter of Section 18, Township 9 North, Range 1 West, Monroe County, Indiana, described as follows: Beginning at a point which is 2571.40 feet North and 2561.10 feet West of the Southeast corner of the Southeast quarter of said Section 18, Township 9 North, Range 1 West, thence North 81 degrees 49 minutes East for a distance of 930.42 feet, thence North 57 degrees 13 minutes East for a distance of 319.94 feet, and to the centerline of Maple Grove Road, thence South 1 degrees 15 minutes East, over and along the centerline of Maple Grove Road, for a distance of 520.00 feet, thence North 89 degrees 30 minutes West for a distance of 498.37 feet, thence North for a distance of 6.65 feet, thence North 45 degrees 03 minutes West for a distance of 108.05 feet, thence South 89 degrees 54 minutes West for a distance of 484.77 feet, thence North 2 degrees 44 minutes West for a distance of 99.25 feet, thence South 86 degrees 24 minutes West for a distance of 142.37 feet, thence North 6 degrees 34 minutes West for a distance of 37.77 feet, and to the place of beginning. Containing 7.00 acres, more or less.
- 2. A part of the Southeast quarter and a part of the Northeast quarter of Section 18, Township 9 North, Range 1 West, Monroe County, Indiana, described as follows: Beginning at a point that is 2571.40 feet North and 2561.10 feet West of the Southeast corner of the said Southeast quarter, thence North 81 degrees 49 minutes 00 seconds East for a distance of 930.42 feet, thence North 57 degrees 13 minutes 00 seconds East for a distance of 319.94 feet, and to the centerline of Maple Grove Road, thence Northwesterly, over and along the centerline of Maple Grove Road, by the following courses and distances; North 5 degrees 38 minutes 20 seconds West 77.76 feet, North 28 degrees 11 minutes 00 seconds West 100.00 feet, North 39 degrees 47 minutes 00 seconds West 100.00 feet, North 49 degrees 59 minutes 00 seconds West 113.00 feet, North 55 degrees 33 minutes 00 seconds West 113.00 feet, North 50 degrees 44 minutes 00 seconds West 100.00 feet, North 50 degrees 43 minutes 00 seconds West 100.00 feet, North 40 debrees 43 minutes 00 seconds West 100.00 feet, North 38 degrees 37 minutes 00 seconds West 307.89 feet, thence North 89 degrees 59 minutes West for a distance of 337.50 feet, and to the West line of the said Northeast and Southeast quarter, thence South 0 degrees 27 minutes 00 seconds East for a distance of 1376.44 feet, over and along the said West line, thence East for a distance of 84.00 feet, and to the place of beginning. Containing 27.12 acres, more or less.
- 3. With the further exception of Stone Hedge Manor First Addition as recorded in the office of the Recorder of Monroe County, Indiana in Plat Book 6 at page 29.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
