

SALARY ORDINANCE FOR APPOINTED OFFICERS AND EMPLOYEES

AN ORDINANCE FIXING SALARIES OF APPOINTED OFFICERS AND EMPLOYEES OF THE CITY OF BLOOMINGTON, INDIANA, FOR THE YEAR 1973.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That from and after the 1st day of October, 1973, the salary and pay schedule for the following appointed officers and employees of the City of Bloomington, Indiana, be fixed as follows:

TO THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

I, the undersigned, Francis X. McCloskey, Mayor of the City of Bloomington, Indiana, as required by chapter 107 of the Acts o- 1959, IC 1971, 18-2-1-10, hereby fix the salaries and pay schedule for the following appointed officers and employees of the said City of Bloomington, Indiana, beginning October 1, 1973, and continuing thereafter until duly changed, and request that such salary rates be approved by the Common Council, to-wit:

Director of Personnel . . . . . \$10,500.00 annually  
Secretary . . . . . \$ 5,720.00 annually

SECTION 2. That the rates shown as wages and salaries for the positions listed above are the maximum rates.

SECTION 3. That this ordinance shall be in full force an effect from and after its approval by the Mayor.
