ORDINANCE NO. 73-61

AN ORDINANCE CONCERNING THE ANNEXATION  
OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana,  
is adjacent to the real estate described herein,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL  
OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the  
same is, hereby annexed to and declared a part of the City of  
Bloomington, Indiana, to-wit:

A part of Sections 18, 19, 20, 28, and 29, Township  
9 North, Range 1 West in Monroe County, Indiana,  
described as follows:

Beginning at a point, said point being the inter-  
section of the West right-of-way of College Avenue  
and the South right-of-way of Seventeenth (17th)  
Street, thence West along the South right-of-way  
of Seventeenth (17th) Street to that point where  
State Highway #46 departs Seventeenth (17th) Street,  
thence West along the South right-of-way of State  
Highway #46 to the point where State Highway #46  
intersects the West Section line of Section 19,  
Township 9 North, Range 1 West, thence North along said  
Section line to the Southwest corner of Section 18,  
Township 9 North, Range 1 West, thence North  $0^{\circ} 47.4'$   
West 2622.21 feet, thence North  $89^{\circ} 36.0'$  East  
718.72 feet, thence South  $0^{\circ} 49.0'$  East 520.88 feet,  
thence South  $89^{\circ} 0.0'$  West 120.00 feet, thence  
South  $0^{\circ} 49.0'$  East 170.00 feet, thence South  $89^{\circ}$   
 $55.1'$  West 30.00 feet, thence South  $0^{\circ} 49.0'$  East  
296.86 feet, thence South  $35^{\circ} 50.2'$  East 169.47 feet,  
thence South  $71^{\circ} 09.8'$  West 102.26 feet, thence South  
 $19^{\circ} 06.8'$  East 1282.06 feet, thence South  $7^{\circ} 00.0'$   
East 60.00 feet, thence South  $83^{\circ} 15.2'$  West 23.96  
feet, thence South  $6^{\circ} 44.8'$  East 192.05 feet, thence  
 $89^{\circ} 50.5'$  West 925.00 feet, thence South to the  
North right-of-way of State Highway #46, thence East  
along the North right-of-way of State Highway #46  
to the point where said North right-of-way inter-  
sects the North right-of-way of Seventeenth (17th)  
Street, thence East along the North right-of-way  
of Seventeenth (17th) Street to the intersection  
of said North right-of-way and the West right-of  
way of College Avenue, thence South along the West  
Right-of-way of College Avenue, and to the point of  
beginning.

The above described real estate includes Sections of Seventeenth Street and State Highway #46, and Stone Hedge Manor, 1st Addition, as platted and recorded in Plat Book 6, Page 29, Monroe County Recorder's Office, Bloomington, Indiana.

SECTION 2. Be it further ordained, that the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.
