

ORDINANCE NO. 73-84

AN ORDINANCE CONCERNING THE ANNEXATION
OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana, is adjacent to the real estate described herein,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

Part of the Southwest quarter of Section Eleven (11), Township Eight (8) North, Range One (1) West in Monroe County, Indiana, more particularly described as follows, to-wit: Commencing at the Northwest corner of the said quarter section, thence South Zero (00)degrees Zero (00) minutes (assumed bearing) along the West line of the said quarter section Nine Hundred Seventy and six-tenths (970.6) feet; thence South Eighty-six (86) degrees Thirty-seven (37) minutes East Four Hundred Sixty and Sixty-three hundredths (460.63) feet to the real point of beginning; thence North Three (3) degrees Twenty-three (23) minutes East One Hundred Thirty-one and Fifty-two hundredths (131.52) feet; thence South Eighty-six (86) degrees Thirty-seven (37) minutes East One Hundred Ninety-Five (195) feet to the center line of Sare Road; thence South Zero (00) degrees Zero (00) minutes along the center line of said Sare Road One Hundred Thirty-one and Seventy-five hundredths (131.75) feet; thence North Eighty-Six degrees Thirty-seven (37) minutes West Two Hundred Two and Seventy-seven hundredths (202.77) feet to the place of beginning, containing Sixty hundredths (0.60) of an acre, more or less.

Said above described real estate is located on Sare Road.

SECTION 2. Be it further ordained, that the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.
