ORDINANCE NO. 72-11

AN ORDINANCE TO AMEND THE BLOOMINGTON
ZONING MAP, DATED JULY 13, 1967

WHEREAS, The Common Council of the City of Bloomington, Indiana passed a zoning ordinance and adopted a zoning map on July 18, 1950, and

WHEREAS, said zoning ordinance and map are now incorporated in the "Bloomington Municipal Code" as Title 20 of said Code, and

WHEREAS, said City Zoning Ordinance includes certain contiguous unincorporated areas within a radius of two miles from the City, as shown on the map entitled "Bloomington Zoning Map II", dated July 13, 1967, and

WHEREAS, The City Plan Commission has recommended that said "Bloomington Zoning Map II", be amended by the rezoning of certain property.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174 OF THE 1947 ACTS, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA:

SECTION 1. That the Map entitled "Bloomington Zoning Map II" dated July 13, 1967, be amended to rezone the following described land in Monroe County, Indiana, from its present R-1 ONE FAMILY ZONE classification to a R-3 MULTIPLE DWELLING ZONE, to-wit:

A part of the Southeast quarter of Section Twenty-five (25), Township Nine (9) North, Range Two (2) West, Monroe County, Indiana, described as follows: Beginning at a point that is 233.71 feet East and 827.68 feet South of the Northwest corner of the said Southeast quarter, thence South 89 degrees 21 minutes 30 seconds East for 345.42 feet, thence North 03 degrees 10 minutes 40 seconds East for 126.11 feet, thence West for 350 feet and to the point of beginning. Containing in all one (1) acre, more or less. Said land is located East of Curry Pike about 3/8 of a mile North of Vernal Pike.

SECTION 2. That this ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
