ORDINANCE NO. 72-19

AN ORDINANCE AMENDING THE CITY CODE OF BLOOMINGTON  
BY AMENDING 7.12.040 ENTITLED "DISPOSITION OF FUNDS"  
AND 7.16.090 ENTITLED "IMPOUNDING -- NOTICE TO  
OWNER -- REDEMPTION", AND REPEALING 7.16.100 ENTITLED  
"IMPOUNDING TIME OF KEEPING -- DISPOSITION OF UNCLAIMED  
DOGS".

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF  
BLOOMINGTON, INDIANA:

SECTION 1. The City Code of Bloomington is hereby amended  
by amending Section 7.12.040 to read as follows:

7.12.040 Disposition of funds. All funds paid under  
Section 7.16.090, shall be paid to the city controller and all  
moneys so paid shall be placed in a special fund and shall be used  
in carrying out the provisions of this title.  
(Prior code §5-4).

SECTION 2. The City Code of Bloomington is hereby amended  
by amending Section 7.16.090 to read as follows:

7.16.090 Impounding -- Notice to Owner -- Redemption.  
Not later than twenty-four hours after the impounding of any dog,  
if practicable to do so, the owner shall be notified. The owner  
of any dog so impounded may reclaim such dog upon payment of the  
license fee, if unpaid, and of all costs and charges incurred by  
the city for impounding and maintenance of such dog. The following  
charges shall be paid to the humane officer:

- (1) For impounding any dog:

- (2) For keeping any dog (each day  
or part thereof) ..... \$1.00  
(Prior code §5-15)

SECTION 3. The City Code of Bloomington is hereby amended  
by repealing Section 7.16.100.
