

## ORDINANCE NO. 72-24

AN ORDINANCE CONCERNING THE ANNEXATION  
OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana is adjacent to the real estate described herein

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

A part of the Northeast quarter of Section 8, Township 8 North, Range 1 West, Monroe County, Indiana, described as follows: beginning at a point that is 1177.72 feet North and 775.50 feet West of the Southeast corner of the said quarter, said point being in the centerline of South Rogers Street, thence North  $86^{\circ} 56' 30''$  East for a distance of 564.90 feet, and to the West right-of-way line of the Illinois Central Railroad, thence Northwesterly, over and along the West right-of-way line of the said Illinois Central Railroad, by the following courses and distances; North  $26^{\circ} 16' 45''$  West 219.72 feet, North  $28^{\circ} 53'$  West 107.00 feet, North  $31^{\circ} 30'$  West 140.27 feet, North  $31^{\circ} 16'$  West 410.00 feet, North  $43^{\circ} 59' 24''$  West 209.77 feet, and to the centerline of South Rogers Street, thence South  $1^{\circ} 00'$  East, over and along the centerline of South Rogers Street, for a distance of 600.00 feet, thence continuing over and along the centerline of South Rogers Street  $1^{\circ} 02'$  East for a distance of 341.96 feet, and to the place of beginning. Containing 6.08 acres, more or less.

SECTION 2. Be it further ordained, that the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.
