ORDINANCE NO. 72-37

AN ORDINANCE CONCERNING THE ANNEXATION  
OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana  
is adjacent to the real estate described herein

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL  
OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the  
same is, hereby annexed to and declared a part of the City of  
Bloomington, Indiana, to-wit:

A part of the Southwest quarter of  
Section 28, Township 9 North, Range 1  
West, Monroe County, Indiana, described  
as follows: Beginning at a point which  
is 24.00 feet West and 42.82 feet North  
of the Southeast corner of the said  
Southwest quarter, thence North and  
parallel with the East line of the said  
quarter for a distance of 72.51 feet,  
thence West and parallel with the South  
line of the said quarter for a distance  
of 148.55 feet, thence South and parallel  
with the East line of the said quarter for  
a distance of 72.51 feet, thence East and  
parallel with the South line of the said  
quarter for a distance of 148.55 feet, and  
to the place of beginning; together with a  
strip of ground of the even width of 22.82  
feet running along the entire south side  
of the above described real estate, pro-  
vided however, said 22.82 foot strip of  
real estate shall at all times be subject  
to the right and authority of any govern-  
mental organization to utilize the same  
for the purposes of any form of highway  
right-of-way construction.

SECTION 2. Be it further ordained, that the boundaries  
of the City of Bloomington shall be, and the same are, hereby  
declared to be extended so as to include all of the real  
estate hereinabove described as a part of the City of Bloomington,  
Indiana.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.
