ORDINANCE NO. 72 - 48

AN ORDINANCE CONCERNING THE ANNEXATION  
OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana  
is adjacent to the real estate described herein

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL  
OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the  
same is, hereby annexed to and declared a part of the City of  
Bloomington, Indiana, to-wit:

A part of the Northwest quarter of Section 28,  
Township 9 North, Range 1 West, Bloomington  
Township, Monroe County, Indiana, more parti-  
cularly described as follows:

Beginning at a 3/4 inch iron pipe which is 1376.63  
feet West and 50.00 feet North, more or less, of  
the Southeast corner of the aforesaid Northwest  
quarter of Section 28, said pipe being also on the  
North right-of-way line of Indiana State Highway  
Number 46 Bypass; thence S 90° W (assumed bearing)  
along the said right-of-way line 40.00 feet to  
a 3/4 inch iron pipe; thence N 0° 12.08' E 107.30  
feet to an existing 1/2 inch iron pipe; thence S  
90° W 208.81 feet to a 3/4 inch iron pipe which is  
on the Eastern right-of-way line of Indiana State  
Highway Number 37, said pipe being also in a curve  
to the right, said curve having a central angle of  
6° 11.07" and a radius of 2809.79 feet length;  
thence along the arc of said curve which is the Eastern  
right-of-way line of said Highway Number 37 303.29  
feet to a 3/4 inch iron pipe, said arc having a  
chord bearing N 11° 20.61' E and a chord length of  
303.14 feet; thence leaving the right-of-way of said  
Highway Number 37 S 75° 08.45' E 7.82 feet to a  
3/4 inch iron pipe; thence N 87° 51.73' E 74.37 feet  
to an existing 1/2 inch iron pipe; thence S 0° 22.05'  
E 40.00 feet to an existing 1/2 inch iron pipe; thence  
N 87° 51.73' E 104.38 feet to an existing 3/4 inch  
iron pipe; thence S 0° 22.05' E 369.19 feet to the  
point of beginning. Containing 1.506 acres, more  
or less, and subject to all legal rights-of-way and  
easements.
