ORDINANCE NO. 72-61

AN ORDINANCE CONCERNING THE ANNEXATION
OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana,
is adjacent to the real estate described herein;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL
OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the
same is, hereby annexed to and declared a part of the City of
Bloomington, Indiana, to-wit:

Part of the Southeast Quarter of Section 10,
Township 8 North, Range 1 West in Monroe County,
Indiana, more particularly described as follows:

Beginning on the East line of the said South-
east Quarter Section, South 00 degrees 06
minutes 30 seconds West, 377.03 feet from the
Northeast corner of the said Southeast Quarter
Section (the said place of beginning is the
Southeast corner of "SYCAMORE KNOLLS ADDITION-
SECTION SIX", the plat of which is recorded in
Plat Book 5, page 87 in the office of the Re-
corder of Monroe County, Indiana) (the next
four courses are along the Southern bounds of
the said Addition); thence South 63 degrees
26 minutes 30 seconds West 289.10 feet; thence
South 13 degrees 08 minutes 30 seconds East
37.00 feet; thence South 68 degrees 00 minutes
00 seconds west 381.33 feet; thence South 76
degrees 00 minutes 00 seconds West 150.00 feet;
thence South 09 degrees 39 minutes 18 seconds
East 510.91 feet; thence South 55 degrees 40
minutes 18 seconds West 31.80 feet; thence South
00 degrees 48 minutes 44 seconds West 171.70
feet; thence South 89 degrees 11 minutes 16
seconds East 560.37 feet; thence North 00 de-
grees 06 minutes 30 seconds East 79.93 feet; thence
South 89 degrees 53 minutes 30 seconds East
130.00 feet to the East line of the said South-
east Quarter Section; thence North 00 degrees
06 minutes 30 seconds East along the said East
line 372.40 feet to a point which lies south
00 degrees 06 minutes 30 seconds West, 970.60
feet from the Northwest corner of the said
Southwest Quarter Section; thence south 86 de-
grees 30 minutes 30 seconds East 460.63 feet;
thence North 03 degrees 29 minutes 30 seconds
East 131.52 feet; thence South 86 degrees 30
minutes 30 seconds East 195.00 feet to the
center line of Sare Road; thence North 00 de-
grees 06 minutes 30 seconds East along the
center line of Sare Road 191.85 feet, thence
North 86 degrees 30 minutes 30 seconds West
663.40 feet to the West line of the said South-

west Quarter Section; thence North 00 degrees 06 minutes 30 seconds East along the said West line 269.97 feet to the place of beginning, containing 17.861 acres, more or less.

Said above described real estate is commonly known as Sycamore Knolls Heights.

SECTION 2. Be it further ordained, that the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.
