

ORDINANCE NO. 72-62

AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana, is adjacent to the real estate described herein,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

A part of the Southeast Quarter of Section Eight (8), Township Eight (8) North, Range One (1) West, in Monroe County, Indiana, described as follows: Beginning at a point at the Northeast corner of Rockport Road and Coolidge Street, said point being the intersection of the East right-of-way of Rockport Road and the North right-of-way of Coolidge Street, running thence East along the North right-of-way of Coolidge Street to a point on the Northwest corner of Coolidge Street and Brown Street, said point being the intersection of the North right-of-way of Coolidge Street and the West right-of-way of Brown Street, running thence South along the West right-of-way of Brown Street to the Northeast corner of Lot Number 132 of Broadview Park First Addition; thence South along the East lot lines of lots 132, 133, 134, 135, 136, 137, 138, and 139, to the Southeast corner of Lot Number 139 of Broadview Park First Addition; thence West along the South lot line of Lot Number 139 to the Southwest corner of Lot 139; thence North along the West lot line of 139 to the Northwest corner of Lot 139; thence West along the South lot line of Lot Number 141 to the Southwest corner of Lot Number 141; thence North along the West lot lines of Lots 141, 142, 143, 144, 145, 146, and 147 to the Northwest corner of Lot 147; thence West along the South right-of-way of Coolidge Street to the Intersection of the South right-of-way of Rockport Road; thence North on the East right-of-way of Rockport Road to the point of beginning.

SECTION 2. Be it further ordained, that the boundaries of the City of Bloomington shall be, and the same are, hereby

declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.
