

ORDINANCE NO. 72-65

AN ORDINANCE CONCERNING THE ANNEXATION  
OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana,  
is adjacent to the real estate described herein,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF  
THE CITY OF BLOOMINGTON, INDIANA:

Section 1. That the following described land be, and the  
same is, hereby annexed to and declared a part of the City of  
Bloomington, Indiana, to-wit:

A part of the Northeast Quarter of Section  
Three (3), Township Eight (8) North, Range  
One (1) West, Monroe County, Indiana, bounded  
and described as follows, to-wit: Beginning  
at a point three hundred and twenty (320) feet  
East and eighteen and seven tenths (18.7) feet  
North of the Southwest corner of said quarter  
section, running thence North one hundred sixty-  
three and eighty-five hundredths (163.85) feet,  
running thence East one hundred fifty (150)  
feet, running thence North one thousand seventy-  
three (1073) feet, running thence west to the  
West right-of-way line of South High Street,  
running thence South along said right-of-way  
line one thousand two hundred thirty-six and  
eighty-five hundredths (1236.85) feet, running  
thence east to the point of beginning. Said  
description bounding what is commonly known as  
lots 3-16 in Rogers Heights, an unplatted tract  
of land, and that stretch of South High Street  
lying adjacent to said lots.

SECTION 2. Be it further ordained, that the boundaries of  
the City of Bloomington shall be, and the same are, hereby declared  
to be extended so as to include all of the real estate hereinabove  
described as a part of the City of Bloomington, Indiana.

SECTION 3. This ordinance shall be in full force and effect  
from and after its passage, promulgation, approval by the Mayor  
and publication in accordance with the law.
