

ORDINANCE NO. 72- 68

AN ORDINANCE CONCERNING THE ANNEXATION
OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana, is adjacent to the real estate described herein,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

A part of the Southwest quarter of Section Twenty-Seven (27) Township Nine (9) North, Range One (1) West, in Monroe County, Indiana, and bounded as follows: Beginning on the West line of said Section Twenty-Seven (27) at a point eight hundred ninety-four and seventy-five hundredths (894.75) feet North of the Southwest corner of said Section Twenty-Seven (27); thence East five hundred forty-one (541) feet; thence South one hundred twenty and seventy-five hundredths (120.75) feet; thence West five hundred forty-one (541) feet, and to the West line of Section Twenty-Seven (27) (center line of Fee Lane); thence North one hundred Twenty and Twenty-Five Hundredths (120.75) feet to the point of beginning.

Also, the South one-half ($\frac{1}{2}$) of the following described real estate: A part of the southwest quarter of Section 27, Township 9 North, Range 1 West, bounded as follows: Beginning at a point one thousand fifteen and five tenths (1015.5) feet North of the southwest corner of said Section 27 and on the west line of said Section; thence East five hundred and forty-one (541) feet; thence South one hundred twenty point seventy-five hundredths (120.75) feet; thence west five hundred and forty-one (541) feet and to the West line of said Section 27, being the center line of Fee Lane; thence North One Hundred Twenty, point seventy-five (120.75) feet to the place of beginning.

Said above described real estate is located at 1606 North Fee Lane, Bloomington, Monroe County, Indiana.

SECTION 2. Be it further ordained, that the boundaries of the City of Bloomington shall be, and the same are, hereby declared

to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.
