

APPROPRIATION ORDINANCE No. 72-1

AN ORDINANCE SPECIALLY APPROPRIATING FROM THE GENERAL FUND and SPECIAL FUNDS, EXPENDITURES NOT OTHERWISE APPROPRIATED of the CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, TO MEET THE EXTRAORDINARY EMERGENCIES FOUND TO EXIST IN THE VARIOUS DEPARTMENTS.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA:

SECTION I. That there be and hereby is appropriated from the General Fund of said City, funds not otherwise appropriated, to meet the extraordinary emergencies found to exist for the expenditures of more money for the current year of 1972, than was set out in detail in the budget as finally adopted, and appropriations as finally made, the following sums:
