ORDINANCE NO. 71-7

AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND  
CONTIGUOUS TERRITORY PURSUANT TO THE FILING OF A PETITION  
FOR VOLUNTARY ANNEXATION.

WHEREAS, the Boundary of the City of Bloomington, Indiana, is  
adjacent to the real estate described herein and

WHEREAS, the owners of the lands hereinafter described have  
submitted to the Common Council of the City of Bloomington, Indiana,  
a petition for and on their behalf for annexation of certain territory  
of which the petitioners are the owners.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF  
THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described territory be, and the  
same is, hereby annexed to and declared a part of the City of Bloomington,  
Indiana, to-wit:

A part of the Southwest Quarter of Section 28, Township 9  
North, Range 1 West, in Monroe County, Indiana, bounded  
and described as follows, to-wit: Beginning at a point  
that is 1056 feet West and 20 feet North of the Southeast  
corner of the said Southwest Quarter, said point being on  
the North right-of-way line of East 17th Street where the  
same is intersected by an old established line fence; thence  
running North over and along the said old established line  
fence for a distance of 290 feet, and to the intersection  
of an East and West established line fence; thence running  
South 88 degrees West over and along the East and West  
established line fence for a distance of 369 feet and to  
the East right-of-way line of the new State Highway 37;  
thence running South 4 degrees East over and along the  
said East right-of-way line of the new State Highway 37  
for 165 feet and to the Northwest corner of the Sinclair  
Oil Co. Real Estate; thence, running North 87 degrees  
30 minutes East for 82 feet; thence running South 3 degrees  
15 minutes East for 37 feet; thence running North 87 degrees  
30 minutes East for 37 feet; thence running 3 degrees 15  
minutes East for 6.50 feet; thence running North 88 degrees  
East for 53 feet; thence running South 2 degrees 45 minutes  
East for 81.5 feet and to the North property line of East  
Seventeenth Street; thence running North 88 degrees East  
over and along the said North property line of East Seventeenth  
Street for 182 feet and to the place of beginning.


ALSO, a part of the said Southwest Quarter, Township Range and  
County aforesaid, beginning 1240 feet West and 20 feet North  
of the Southeast corner of the said Quarter; thence running  
North 2 degrees 45 minutes West 81 1/2 feet; thence running  
South 88 degrees West 53 feet; thence running South 81.5 feet  
more or less and to the North line of East 17th Street; thence  
running East 53 feet and to the place of beginning.

Said lands are located North of Seventeenth Street and East of  
Walnut Street.

SECTION 2. BE IT FURTHER ORDAINED, That the boundaries of the City  
of Bloomington shall be, and the same are, hereby declared to be extended  
so as to include all of the real estate hereinabove described as a part  
of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from  
and after its passage, promulgation, approval by the Mayor and publication  
in accordance with the law.
