AN ORDINANCE TO AMEND THE BLOOMINGTON  
ZONING MAP, DATED JULY 13, 1967

WHEREAS, The Common Council of the City of Bloomington, Indiana, passed a zoning ordinance and adopted a zoning map on July 18, 1950, and

WHEREAS, said zoning ordinance and map are now incorporated in the "Bloomington Municipal Code" as Title 20 of said code, and

WHEREAS, said City Zoning Ordinance includes certain contiguous unincorporated areas within a radius of two miles from the City, as shown on the map entitled "Bloomington Zoning Map II", dated July 13, 1967, and

WHEREAS, The City Plan Commission has recommended that said "Bloomington Zoning Map II", be amended by the rezoning of certain property.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174 OF THE 1947 ACTS, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA:


SECTION 1. That the Map entitled "Bloomington Zoning Map II", dated July 13, 1967, be amended to rezone the following described land in Monroe County, Indiana, from its present R-1 ONE-FAMILY ZONE classification to R-4 MOBILE HOME PARK ZONE, to-wit:

A part of the West half of the Northwest Quarter of Section 21, Township 8 North, Range 1 West, Monroe County, Indiana described as follows; beginning at a point that is South 89 degrees 09 minutes West for 565.94 feet from the Northeast corner of the West half of the said Northwest Quarter; thence South 89 degrees 09 minutes West for 700.00 feet; thence South 02 degrees 18 minutes 25 seconds East for 710.00 feet; thence North 89 degrees 09 minutes East for 700.00 feet; thence North 02 degrees 18 minutes 25 seconds West for 710.00 feet and to the point of beginning. Containing in all 11.18 acres more or less.


This land is located South of the City Sewage Plant on Gordon Pike.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.






