ORDINANCE NO. 71-33

AN ORDINANCE AMENDING SECTION 15.72.050 OF THE BLOOMINGTON MUNICIPAL CODE, ENTITLED, "PARKING METERS - DEPOSIT OF COINS" AND REPEALING ORDINANCE NO. 70-40, ENTITLED "AN ORDINANCE REPEALING RATES FOR PARKING IN METERED AREAS AND AN ORDINANCE TO ESTABLISH RATES, HOURS AND LOCATION OF PARKING METERS WITHIN THE DISTRICTS AND ZONES AS SET OUT IN A PARKING PROGRAM FOR THE CITY OF BLOOMINGTON DATED MAY, 1970".

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That Section 15.72.050 of the Bloomington Municipal Code is amended to read as follows:

Whenever a vehicle shall be parked in a separate parking space, where a parking meter has been installed, the person parking such vehicle shall deposit coins of the United States, if such meter displays the signal showing that legal parking is only permitted on such deposit, as follows: One penny for the privilege of parking such vehicle in such space for a period of twelve minutes and one penny for such privilege for each twelve minute interval up to, and including, one hundred and twenty minutes; provided, however, that for the privilege of parking such vehicle in such space for a period of sixty minutes the deposit of a five cent piece shall be permissible and for the privilege of parking such vehicle in such space for a period of one hundred and twenty minutes the deposit of two five cent pieces or one dime shall be permissible. Notice to the public shall be given by appropriate signs setting forth the length of time for which parking is permitted and the conditions thereof. These may be upon the parking meter stand or in the immediate vicinity. Any vehicle which remains in a separate parking space after the time has elapsed for which the privilege of parking in such space has been paid is hereby determined to be illegally parked.

SECTION 2. That Ordinance No. 70-40, entitled, "AN ORDINANCE REPEALING RATES FOR PARKING IN METERED AREAS AND AN ORDINANCE TO ESTABLISH RATES, HOURS AND LOCATION OF PARKING METERS WITHIN THE DISTRICTS AND ZONES AS SET OUT IN A PARKING PROGRAM FOR THE CITY OF BLOOMINGTON DATED MAY, 1970" is hereby repealed.

SECTION 3. That this ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.
