ORDINANCE NO. 71-61

AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND
CONTIGUOUS TERRITORY PURSUANT TO THE FILING OF A PETITION
FOR VOLUNTARY ANNEXATION.

WHEREAS, the Boundary of the City of Bloomington, Indiana, is
adjacent to the real estate described herein and

WHEREAS, the owners of the lands hereinafter described have
submitted to the Common Council of the City of Bloomington, Indiana,
a petition for and on their behalf for annexation of certain territory
of which the petitioners are the owners.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF
THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described territory be, and the
same is, hereby annexed to and declared a part of the City of Bloomington,
Indiana, to-wit:

A part of the Northeast Quarter of Section 35, Township 9 North,
Range 1 West, described as follows, to-wit: Beginning at a point
that is 1279.63 feet East and 213.12 feet North of the Southwest
corner of the said Northeast Quarter of said Section 35, and in
the center line of State Highway Number 45; thence running South
12 degrees 30 minutes East for a distance of 214 feet; thence
running North 80 degrees 30 minutes East for a distance of 206
feet; thence running North 9 degrees West for a distance of 201.5
feet and to the center line of State Road Number 45; thence running
over and along the center line of the said State Highway Number 45
the following courses and distances: South 86 degrees West 50 feet;
South 83 degrees 15 minutes West 136 feet and South 81 degrees 30
minutes West 35 feet and to the place of beginning, containing in
all 1.00 acre, more or less.


Also, A part of the Southeast Quarter of Section 35, Township 9
North, Range 1 West, Monroe County, Indiana: Beginning at a point
that is 1723.94 feet East and 356.49 feet South of the Northwest
corner of the Southeast Quarter of Section 35, Township 9 North,
Range 1 West; thence running North 10 degrees West for a distance
of 136.8 feet and to the South right of way line of State Road 45;
thence running South 82 degrees and 30 minutes East over and along
the said South right of way line of State Road 45 for 38 feet; thence
North 80 degrees and 30 minutes East for 137 feet; thence leaving
the said South right of way line of State Road 45 and running South
37 degrees and 30 minutes East for 116 feet; thence South 56 degrees
and 30 minutes West for 156 feet; thence North 74 degrees and 15
minutes West for 90 feet and to the place of beginning, containing
in all 0.57 acres, more or less.

Both lots are located on East Tenth Street in the Grandview Hills
Area.

SECTION 2. BE IT FURTHER ORDAINED, That the boundaries of the City
of Bloomington shall be, and the same are, hereby declared to be extended
so as to include all of the real estate hereinabove described as a part
of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from
and after its passage, promulgation, approval by the Mayor and publication
in accordance with the law.
