

ORDINANCE NO. 71-62

AN ORDINANCE TO AMEND TITLE 15 ENTITLED  
"VEHICLES AND TRAFFIC" BY AMENDING SECTION  
15.64.410 ENTITLED "NO PARKING ZONES", SECTION  
15.64.370 ENTITLED "RESTRICTED PARKING ZONES",  
AND SECTION 15.76.010 ENTITLED "STOP INTERSECTIONS",  
AND SECTION 15.64.290 ENTITLED "LOADING ZONES"

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY  
OF BLOOMINGTON, INDIANA:

SECTION 1. That Section 15.64.410 entitled "No Parking  
Zones" be amended by adding thereto the following:

- a. The south side of East Seventh Street  
from Indiana Avenue to Woodlawn Avenue.
- b. The west side of North Fairview Street  
from West Ninth Street to West Eleventh Street.
- c. Both sides of North Jefferson Street from  
East Third north to the first east-west alley.
- d. Both sides of the 200 block of South Roosevelt  
Avenue, including the cul-de-sac.
- e. Both sides of Jefferson Street between Seventh  
and Tenth Streets. Within six (6) feet of paved surface.
- f. Both sides of Faculty Avenue from Third Street  
to Atwater Avenue.

SECTION 2. That Section 15.76.010 entitled "Stop  
Intersections" be amended by adding thereto the following:

- a. West Third Street and Maple Street shall be  
designated a Three-Way Stop.

SECTION 3. That Section 15.64.290 entitled "Loading  
Zones" shall be amended by adding thereto the following:

- a. The west side of North Jordan Avenue fronting  
the property designated as 105 North Jordan Avenue.

SECTION 4. That Section 15.64.370 entitled "Restricted  
Parking Zones" be amended by adding thereto the following:

- a. The east side of South Lincoln Street extending  
from Third Street to the first alley south of East  
Third Street shall be designated as an one-hour  
parking zone.
- b. The south side of East Third Street extending east  
from Lincoln Street to the first alley east of Lincoln

Street shall be designated as an one-hour parking zone.

SECTION 5. That this ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.
