SECTION 1. That there be and hereby is appropriated from the General Fund of said City, not otherwise appropriated, to meet the extraordinary emergencies found to exist for the expenditures of more money for the current year of 1971, than was set out in detail in the budget as finally adopted, and appropriations as finally made, the following sums:
