

ORDINANCE OF THE CITY OF BLOOMINGTON,
COUNTY OF MONROE, STATE OF INDIANA

ORDINANCE NO. 70-11

AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND
CONTIGUOUS TERRITORY PURSUANT TO THE FILING OF A PETITION
FOR VALUNTARY ANNEXATION.

WHEREAS, the Boundary of the City of Bloomington, Indiana is
adjacent to the real estate described herein and

WHEREAS, the owners of the lands hereinafter described have
submitted to the Common Council of the City of Bloomington, Indiana,
a petition for and on their behalf for annexation of certain territory
of which the petitioners are the owners.

NOW, THEREFORE, BE ORDAINED BY THE COMMON COUNCIL OF
THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described territory be, and
the same is, hereby annexed to and declared a part of the City of
Bloomington, Indiana, to-wit:

A part of the Northwest Quarter of Section 1, Township 8 North,
Rane 2 West, Monroe County, Indiana, described as follows:
Beginning at a point that is 530.91 feet East and 495.59 feet
South of the Northwest corner of the said Northwest Quarter;
thence South 89 degrees 27 minutes 15 seconds East for 293.00
feet and to the West line of HIGHLAND VILLAGE 10TH ADDITION as
plated; thence South 00 degrees 02 minutes 35 seconds East along
the said West line of HIGHLAND VILLAGE 10TH ADDITION as plated for
1520.27 feet; thence North 89 degrees 27 minutes 15 seconds West
for 121.50 feet; thence South 00 degrees 02 minutes 35 seconds
East for 101.82 feet; thence North 88 degrees 29 minutes 35 seconds
West for 155.50 feet; thence South 00 degrees 02 minutes 35 seconds
East for 161.47 feet; thence North 89 degrees 27 minutes 15 seconds
West for 50.00 feet; thence North 00 degrees 02 minutes 35 seconds
West for 112.27 feet; thence South 88 degrees 29 minutes 35 seconds
East for 1.09 feet; thence North 19 degrees 25 minutes 35 seconds
West for 583.41 feet; thence North 66 degrees 50 minutes 25 seconds
East for 245.32 feet; thence North 00 degrees 02 minutes 35 seconds
West for 1010.27 feet and to the point of beginning. Containing in
all 11.55 acres more or less.

Also, A part of the Northwest Quarter of Section 1, Township 8 North,
Range 2 West, Monroe County, Indiana, described as follows: Beginning
at a point that is 2.26 feet East and 492.79 feet South of the North-
west corner of the said Northwest Quarter; thence South 89 degrees
27 minutes 15 seconds East for 528.65 feet; thence South 00 degrees
02 minutes 35 seconds East for 1010.27 feet; thence South 66 degrees
50 minutes 25 seconds West for 245.32 feet; thence South 19 degrees
25 minutes 35 seconds East for 583.41 feet; thence North 88 degrees
29 minutes 35 seconds West for 1.09 feet; thence South 00 degrees 02
minutes 35 seconds East for 112.27 feet; thence North 89 degrees 27
minutes 15 seconds West for 477.44 feet; thence North 00 degrees 38
minutes 30 seconds West for 1765.85 feet and to the point of beginning.
Containing in all 25.61 acres more or less.

The above described land comprising Highland Village 11th and 12th
Additions in Van Buren Township.


SECTION 2. BE IT FURTHER ORDAINED, That the boundaries of the
City of Bloomington shall be, and the same are, hereby declared to be
extended so as to include all of the real estate hereinabove described
as a part of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from
and after its passage, promulgation, approval by the Mayor and publication
in accordance with the law.






