

ORDINANCE NO. 70-16

AN ORDINANCE AMENDING CHAPTER 17 OF THE MUNICIPAL CODE OF THE CITY OF BLOOMINGTON, INDIANA, 1957, ENTITLED "MOTOR VEHICLES AND TRAFFIC" BY AMENDING SECTION 206 THEREOF ENTITLED "STOP INTERSECTIONS": SECTION 195 THEREOF ENTITLED "NO PARKING ZONE": SECTION 194 THEREOF ENTITLED "2 HOUR PARKING": SECTION 197 THEREOF ENTITLED "RESTRICTED PARKING ZONES"

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That Section 206 of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, 1957, entitled "Stop Intersections" shall be amended by adding thereto the following:

1. Olive Street shall stop for Miller Drive.

SECTION 2. That Section 195 of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, 1957, entitled "No Parking Zone" shall be amended by adding thereto the following:

1. The west side of Clark Street from East 3rd to 7th Street shall be designated no parking.
2. The east and west sides of the 700 block of north Forrest Avenue shall be designated no parking.

SECTION 3. That Section 194 of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, 1957, entitled "2 Hour Parking" shall be amended by adding thereto the following:

1. The south side of the 100 block of West 14th Street shall be designated 2 Hour Parking Zone.

SECTION 4. That Section 197 of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, 1957, entitled "Restricted Parking Zones" shall be amended by adding thereto the following:

1. The first three (3) parking meters on the south side of 100 East 4th Street, immediately west of South Washington Street.

SECTION 5. That this Ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.
