ORDINANCE NO. 70-49

AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND  
CONTIGUOUS TERRITORY PURSUANT TO THE FILING OF A PETITION  
FOR VOLUNTARY ANNEXATION

WHEREAS, the Boundary of the City of Bloomington, Indiana is  
adjacent to the real estate described herein and

WHEREAS, the owners of the lands hereinafter described have  
submitted to the Common Council of the City of Bloomington, Indiana,  
a petition for and on their behalf for annexation of certain territory  
of which the petitioners are the owners.

NOW, THEREFORE, BE ORDAINED BY THE COMMON COUNCIL OF  
THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described territory be, and  
the same is, hereby annexed to and declared a part of the City of  
Bloomington, Indiana, to-wit:

A part of the West half of the West half of Section 1,  
Township 8 North, Range 2 West, Monroe County, Indiana  
described as follows: Commencing at an existing 3/4  
inch iron pipe taken as the Northwest corner of the  
Southwest Quarter of said Section 1 and also as the  
Southwest corner of Highland Village, 12th Addition;  
thence South 88 degrees 14 minutes East 140.80 feet  
along the South line of said Highland Village to the  
Point of beginning of this described tract; thence  
continuing South 88 degrees 14 minutes East 374.00 feet  
along the South line of said Highland Village; thence  
South 09 degrees 00 minutes East 406.00 feet; thence  
South 36 degrees 05 minutes, 32 seconds East 511.32 feet  
thence South 71 degrees 00 minutes West 125.00 feet;  
thence North 40 degrees 00 minutes West 256.00 feet;  
thence North 76 degrees 03 minutes 50 seconds West 80.00  
feet; thence South 13 degrees 56 minutes 10 seconds West  
105.00 feet; thence South 28 degrees 38 minutes 41 seconds  
West 99.82 feet; thence South 90 degrees 00 minutes West  
160.00 feet; thence North 00 degrees 58 minutes East 620.00  
feet; thence North 53 degrees 21 minutes 28 seconds West  
193.76 feet; thence North 00 degrees 58 minutes East 105.00  
feet to the Place of Beginning. Containing 6.56 Acres, more  
or less .

ALSO: A part of the West half of the West half of Section 1,  
Township 8 North, Range 2 West, Monroe County, Indiana,  
described as follows: Beginning at an existing 3/4 inch  
pipe taken as the Northwest corner of the Southwest Quarter  
of said Section 1, and also as the Southwest corner of Highland  
Village, 12th Addition; thence South 88 degrees 14 minutes East  
140.80 feet along the South line of said Highland Village; thence  
South 00 degrees 58 minutes West 105.00 feet; thence South 53  
degrees 21 minutes 28 seconds East 193.76 feet; thence South 00  
degrees 58 minutes West 620.00 feet; thence South 90 degrees 00  
minutes West 300.00 feet to the West line of said Section; thence  
North 00 degrees 58 minutes East on said West line 845.00 feet to  
the Place of Beginning. Containing 5.23 Acres more or less.

The above described lands are a part of the Neighborhood Development  
on Gifford Road and is known as Park Square.

SECTION 2. BE IT FURTHER ORDAINED, That the boundaries of the City  
of Bloomington shall be, and the same are, hereby declared to be extended  
so as to include all of the real estate hereinabove described as a part  
of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.
