

AN ORDINANCE DESIGNATING CERTAIN ROADS,
 STREETS AND HIGHWAYS AS SCENIC ROADS
 UNDER THE CITY ZONING ORDINANCE

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON,
 INDIANA:

SECTION 1. The following roads are designated as scenic roads and subject to the restrictions of Ordinance No. 70-50, entitled "An Ordinance Regulating Signs Within the Areas Subject to the Jurisdiction of the City of Bloomington Zoning Ordinance":


- a. New four-lane Highway No. 37 lying within the jurisdiction of the Bloomington Zoning Ordinance.
- b. That part of Highway No. 46 extending from Highway No. 37 southeastward to Highway No. 45 and lying within the jurisdiction of the Bloomington Zoning Ordinance.
- c. All that part of Highway No. 46 lying outside of the city and lying within the jurisdiction of the Bloomington Zoning Ordinance.
- d. All that part of Highway No. 45 lying outside of the city and lying within the jurisdiction of the Bloomington Zoning Ordinance.
- e. All that part of State Road No. 37 extending south from Mel Currie Road to the north corporation line and lying within the jurisdiction of the Bloomington Zoning Ordinance.
- f. All that part of Highway No. 446 extending southward and lying within the jurisdiction of the Bloomington Zoning Ordinance.
- g. Highway No. 146 lying within the jurisdiction of the Bloomington Zoning Ordinance.
- h. Highway No. 346 lying within the jurisdiction of the Bloomington Zoning Ordinance.

SECTION 2. That this ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.
