ORDINANCE NO. 69-13

AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND CONTIGUOUS TERRITORY PURSUANT TO THE FILING OF A PETITION FOR VOLUNTARY ANNEXATION.

WHEREAS, the Boundary of the City of Bloomington, Indiana is adjacent to the real estate described herein and

WHEREAS, the owners of the lands hereinafter described have submitted to the Common Council of the City of Bloomington, Indiana, a petition for and on their behalf for annexation of certain territory of which the petitioners are the owners.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described territory be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

A part of the Southwest Quarter of the Southeast Quarter of Section Twenty-nine (29), Township Nine (9) North, Range One (1) West in Monroe County, Indiana, bounded, and described as follows, to-wit: Beginning at a point that is 429 feet East and 40 feet North of the Southwest corner thereof; thence running North 995.375 feet; thence running West 297 feet; thence running South 995.375 feet; thence running East 297 feet and to the place of beginning, containing seven (7) acres, more or less.

This land is located on the North side of Seventeenth Street about 132 feet East of Monroe Street. It extends East 297 feet and North 1035 1/2 feet.

SECTION 2. BE IT FURTHER ORDAINED, That the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.
