ORDINANCE NO. 69-18

AN ORDINANCE AMENDING CHAPTER 17 OF THE MUNICIPAL CODE OF THE CITY OF BLOOMINGTON, INDIANA, 1957, ENTITLED "MOTOR VEHICLES AND TRAFFIC" BY AMENDING SECTION 195 THEREOF ENTITLED "NO PARKING ZONES" AND SECTION 206 THEREOF ENTITLED "STOP INTERSECTIONS" AND SECTION 207 THEREOF ENTITLED "YIELD INTERSECTIONS"

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That Section 195 of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, entitled "No Parking Zone" be amended by adding thereto the following:

1. The east side of Parkridge from East 3rd Street to Morningside Drive
2. The 300 block of South Jordan on the east side of the street, for a distance of 186 feet South from East 3rd Street.
3. For a distance of 54 feet on South Swain in the 400 block on the east side of the street, south from Atwater Street.


SECTION 2. That Section 206 of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, 1957, entitled "Stop Intersection" shall be amended by adding thereto the following:

1. Woodruff Lane shall stop for Moores Pike
2. South Washington Street at its intersection with East Second Street shall be designated a three way stop intersection


SECTION 3. That Section 207 of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, 1957, entitled "Yield Intersections" shall be amended by adding thereto the following:

1. The traffic on Pine Lane shall yield to traffic on Woodruff Lane
2. The traffic on Bluff Court shall yield to traffic on Pine Lane
