ORDINANCE NO. 69-24

AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND
CONTIGUOUS TERRITORY PURSUANT TO THE FILING OF A PETITION
FOR VOLUNTARY ANNEXATION.

WHEREAS, the Boundary of the City of Bloomington, Indiana is
adjacent to the real estate described herein and

WHEREAS, the owners of the lands hereinafter described have
submitted to the Common Council of the City of Bloomington, Indiana,
a petition for and on their behalf for annexation of certain territory
of which the petitioners are the owners.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF
THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described territory be, and the
same is, hereby annexed to and declared a part of the City of Bloomington,
Indiana, to-wit:

A part of the Northwest Quarter of the Northwest Quarter of
Section 1, Township 8 North, Range 1 West, Monroe County,
Indiana, described as follows to-wit: Beginning on the now
existing Corporation line at a point on the South right-of-
way line of State Highway No. 46, which said point is 415
feet East and 40 feet South of the Northwest corner of said
Quarter Quarter section; thence South 200 feet; thence West
100 feet; thence North 200 feet and to the existing Corpor-
ation line; thence East on said Corporation line 100 feet
to the point of beginning containing one half acre more or
less.

This land is located on the South side of Third Street about
300 feet East of Smith Road.

SECTION 2. BE IT FURTHER ORDAINED, That the boundaries of the City
of Bloomington shall be, and the same are, hereby declared to be extended
so as to include all of the real estate hereinabove described as a part of
the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from
and after its passage, promulgation, approval by the Mayor and publication
in accordance with the law.
