ORDINANCE NO. 69-27

AN ORDINANCE TO AMEND THE BLOOMINGTON  
ZONING MAP, DATED JULY 18, 1950

WHEREAS, The Common Council of the City of Bloomington, Indiana, passed a zoning ordinance and adopted a zoning map on July 18, 1950, which said ordinance and map became effective on November 17, 1950, and

WHEREAS, said zoning ordinance and map are now incorporated in the "Municipal Code of the City of Bloomington, Indiana, 1957", as Chapter 30 of said code, and

WHEREAS, The City Plan Commission has recommended that said Bloomington Zoning Map be amended by the rezoning of certain property.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174 OF THE 1947 ACTS, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA:

SECTION 1. That the Map entitled "Bloomington Zoning Map", dated July 18, 1950, be amended to rezone the following described lots in the City of Bloomington, Monroe County, Indiana, from their present R-1 ONE-FAMILY ZONE classification to an R-3 MULTIPLE DWELLING ZONE, to-wit:

Lots number 413, 414, 418, and 419 in Highland Village 10th Addition, being a part of the Northwest Quarter of Section One (1), Township Eight (8) North, Range Two (2) West in Monroe County, Indiana, as shown by the plat thereof recorded in Plat Book Number 5, at page 65, in the office of the Recorder Of Monroe County, Indiana.

Said lands are located between Harvey Drive and Parkway Drive, and South of the Hall Apartments.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
