ORDINANCE OF THE CITY OF BLOOMINGTON
COUNTY OF MONROE, STATE OF INDIANA

ORDINANCE NO. 69 -34

AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND CONTIGUOUS TERRITORY PURSUANT TO THE FILING OF A PETITION FOR VOLUNTARY ANNEXATION.

WHEREAS, the Boundary of the City of Bloomington, Indiana is adjacent to the real estate described herein and

WHEREAS, the owners of the lands hereinafter described have submitted to the Common Council of the City of Bloomington, Indiana, a petition for and on their behalf for annexation of certain territory of which the petitioners are the owners.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described territory be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

Beginning at a point on the now existing corporation line, which said point is the northwest corner of Lot Number 1 in Barclay Gardens Addition; thence over and along the south right of way line of Hillside Drive to the northeast corner of Lot Number 8 in Huntington Park Addition, which said point is the northeast corner of Huntington Park Addition; thence South over and along the East line of Huntington Park Addition to the southeast corner of said Huntington Park Addition; thence West over and along the south line of Huntington Park Addition, which said line is the South right of way line of Short Street to the Southwest corner of Huntington Park Addition, which said corner is on the West right of way line of Olive Street; thence North over and along the West right of way line of Olive Street to the Southeast corner of Lot Number 112 of Barclay Gardens Addition, which said corner is the Southeast corner of Barclay Gardens Addition; thence West over and along the South line of Barclay Gardens Addition to the Southwest corner of Lot Number 80 of Barclay Gardens Addition; thence North along and on the West line of Lot Number 80 to a point on the South line of Lot Number 79 which is 20 feet West of the Southeast corner of said Lot Number 79; thence West over and along the South line of Lots 79 through 68, inclusive, to the East line of Henderson Street and the now existing corporation line; thence North to the point of beginning.

SECTION 2. BE IT FURTHER ORDAINED, That the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.
