ORDINANCE NO. 69- 38

AN ORDINANCE TO AMEND THE BLOOMINGTON
ZONING MAP, DATED JULY 18, 1950

Adopted 9/4/69*

WHEREAS, The Common Council of the City of Bloomington, Indiana, passed a zoning ordinance and adopted a zoning map on July 18, 1950, which said ordinance and map became effective on November 17, 1950, and

WHEREAS, said zoning ordinance and map are now incorporated in the "Municipal Code of the City of Bloomington, Indiana, 1957", as Chapter 30 of said code, and

WHEREAS, The City Plan Commission has recommended that said Bloomington Zoning Map be amended by the rezoning of certain property.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174 OF THE 1947 ACTS, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA:

SECTION 1. That the Map entitled "Bloomington Zoning Map", dated July 18, 1950, be amended to rezone the following described lots in the City of Bloomington, Monroe County, Indiana, from their present Zone classification to an M-2 HEAVY INDUSTRIAL ZONE, to-wit:

The South half of Lots No. 11 and No. 12 in Barclay Gardens Addition to the City of Bloomington, Monroe County, Indiana, excepting there-from 12 feet in width off of the North side thereof to be used as a roadway.

Also, Lots Number 93, 94, 95, 96, 97, 98, and 99 in Barclay Gardens Addition to the City of Bloomington, Monroe County, Indiana.

Also, A part of Lots Number 13, 14 and 15 in Barclay Gardens Addition to the City of Bloomington, Indiana, bounded and described as follows, to-wit: Beginning at a point on the West line of Lot Number 13, 255 feet South of the Northwest corner of said Lot 13; thence South on said West line for a distance of 209.9 feet to the North line of Railroad Street; thence East over and along the North line of Said Street for a distance of 233.5 feet; thence North 192.5 feet; thence West 233.5 feet to the place of beginning.


Also, Eighty (80) feet of even width off of the North end of Lots 89 and 90 in Barclay Gardens Addition to the City of Bloomington, Monroe County, Indiana.

Also, The East half of the North half of Lot Number 92 in Barclay Gardens Addition of the City of Bloomington, Indiana.

These lots are located on Huntington Drive one block South of Hillside Drive.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
