ORDINANCE NO. 68-32

AN ORDINANCE TO AMEND THE BLOOMINGTON ZONING MAP, DATED JULY 18, 1950

WHEREAS, The Common Council of the City of Bloomington, Indiana, passed a zoning ordinance and adopted a zoning map on July 18, 1950, which said ordinance and map became effective on November 17, 1950, and

WHEREAS, said zoning ordinance and map are now incorporated in the "Municipal Code of the City of Bloomington, Indiana, 1957", as Chapter 30 of said code, and

WHEREAS, The City Plan Commission has recommended that said Bloomington zoning Map be amended by the rezoning of certain property.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174, OF THE 1947 ACTS, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA:

SECTION 1. That the Map entitled "Bloomington Zoning Map", dated July 18, 1950, be amended to rezone the following described lots in the City of Bloomington, Monroe County, Indiana, from their present R-2 TWO-FAMILY ZONE classification to an R-3 MULTIPLE DWELLING ZONE, to-wit:

Lots numbered 5, 6, 7, and the North half of lots numbered 9 and 10 in Cedar Hill Addition to the City of Bloomington, Indiana.

Also, a part of Seminary Lot Seventy-six (76) in the City of Bloomington, Indiana, bounded as follows, to-wit: Beginning at a point Thirty (30) poles West of the Northeast corner of said Seminary Lot Seventy-six (76), running thence South One Hundred Thirty-two (132) feet, thence West Sixty-six (66) feet, thence North One Hundred Thirty-two (132) feet, thence East Sixty-six (66) feet to the place of beginning.

Also the following described lands. Beginning at the Northeast corner of South Grant Street and East Second Street; thence East 226 feet; thence North 127 feet; thence West 226 feet; thence South 129 feet to the point of beginning.

These lands are located at the Northeast and the Southeast corners of Second and Grant Streets.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
