ORDINANCE NO. 68- 45

AN ORDINANCE TO AMEND SECTION 1 OF ORDINANCE NO. 29, 1960 AND SECTION 2 OF ORDINANCE NO. 29, 1960, THE SAME BEING SECTION 4 OF CHAPTER 9 OF THE MUNICIPAL CODE OF THE CITY OF BLOOMINGTON, INDIANA, 1957, AND SECTION 2 OF ORDINANCE NO. 29, 1960, THE SAME BEING SECTION 5 OF CHAPTER 9 OF THE MUNICIPAL CODE OF THE CITY OF BLOOMINGTON, INDIANA, 1957, AND SECTION 4 OF ORDINANCE NO. 18, 1957, THE SAME BEING SECTION 7 OF CHAPTER 9 OF THE MUNICIPAL CODE OF THE CITY OF BLOOMINGTON, INDIANA, 1957

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

Section 1. That Section 1 of Ordinance No. 29, 1960, the same being Section 4 of Chapter 9 of the Municipal Code of the City of Bloomington, Indiana, 1957, be amended to read as follows:

" For each space sold in Rosehill Cemetery, sufficient in size to accommodate one grave, the charge shall be \$150.00 if sold to any resident of the City of Bloomington, and the charge shall be \$250.00 if sold to any person residing outside the City of Bloomington."

Section 2. That Section 2 of Ordinance No. 29, 1960, the same being Section 5 of Chapter 9 of the Municipal Code of the City of Bloomington, Indiana, 1957, be amended to read as follows:

" The charge for a lot in Rosehill Cemetery which comprises space for six graves shall be \$900.00 if sold to any resident of the City of Bloomington, and the charge shall be \$1,500.00 if sold to any person residing outside the City of Bloomington."

Section 3. That Section 4 of Ordinance No. 18, 1957, the same being Section 7 of Chapter 9 of the Municipal Code of the City of Bloomington, Indiana, 1957, be amended to read as follows:

" The charges for interment shall be as follows:

(a) For the interment of ashes, the charge shall be \$15.00 if the decedent be a resident of the City of Bloomington, and the charge shall be \$20.00 if the decedent not be a resident of the City of Bloomington.

(b) For the interment of remains of infants, the charge shall be \$20.00.

(c) For the interment of remains requiring larger space than required by an infant, the charge shall be \$80.00 if the decedent be a resident of the City of Bloomington, and the charge shall be \$125.00 if the decedent not be a resident of the City of Bloomington."

Section 4. This Ordinance shall be in force and effect from and after its passage, promulgation and publication in accordance with the law.
