ORDINANCE NO. 68-47

AN ORDINANCE TO AMEND SECTION 306 OF ORDINANCE NO. 10, 1950, THE SAME BEING SECTION 25 OF CHAPTER 24 OF THE MUNICIPAL CODE OF THE CITY OF BLOOMINGTON, INDIANA, ENTITLED "CHARGES"

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

Section 1. That Section 306 of Ordinance No. 10, 1950, the same being Section 25 of Chapter 24 of the Municipal Code of the City of Bloomington, Indiana, be amended as follows:

"At the time of filing an application for approval of a plat, the application shall be accompanied by a certified check or money order of twenty-five dollars plus five dollars for each lot in the proposed subdivision payable to the city controller in the amount to cover the cost of checking and verifying the proposed plat. Upon all proposed subdivisions outside the corporate limits of the City of Bloomington, the application shall be accompanied by a certified check or money order of fifty dollars plus ten dollars for each lot in the proposed subdivision payable to the city controller in the amount to cover the cost of checking and verifying the proposed plat.


Upon the acceptance of the application by the commission, the secretary shall surrender the check or money order to the city controller for deposit in the general fund of the city."

Section 2. This Ordinance shall be in force and effect from and after its passage, promulgation and publication in accordance with the law.
