AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND
CONTIGUOUS TERRITORY PURSUANT TO THE FILING OF A PETITION
FOR VOLUNTARY ANNEXATION.

WHEREAS, the Boundary of the City of Bloomington, Indiana is
adjacent to the real estate described herein and

WHEREAS, the owners of the lands hereinafter described have
submitted to the Common Council of the City of Bloomington, Indiana,
a petition for and on their behalf for annexation of certain territory
of which the petitioners are the owners.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF
THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described territory be, and
the same is, hereby annexed to and declared a part of the City of
Bloomington, Indiana, to-wit:

Beginning at a point on the now existing Corporation Line,
said point being the intersection of the North line of
Davis Street with the West line of Woodlawn Avenue; thence
South on said West line to the Southeast corner of Lot No.
80 in Edgemont Park Addition; thence West to the Southeast
corner of Lot No. 60 in said Addition; thence South to the
Southeast corner of Lot No. 59 in said Addition; thence
West to the Southwest corner of said Lot No. 59 Edgemont
Park Addition; thence North to the North line of Davis
Street; and the existing Corporation line; thence East on
said Corporation Line to the point of beginning.

These four (4) lots are located West of Woodlawn and South
of Davis.

SECTION 2. BE IT FURTHER ORDAINED, That the boundaries of the
City of Bloomington shall be, and the same are, hereby declared to be
extended so as to include all of the real estate hereinabove described
as a part of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect
from and after its passage, promulgation, approval by the Mayor and
publication in accordance with the law.
