

ORDINANCE No. 67-2

An ordinance concerning the annexation of adjacent and contiguous territory.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

Section 1. That the following described territory be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

A part of the West half of the Northwest quarter of Section 16, Township 8 North, Range 1 West, Monroe County, Indiana, more particularly described as follows:

Commencing at the Southeast corner of said West half of the Northwest quarter, in the center of the highway known as State Road #37, thence North 89 degrees 33 minutes 10 seconds West (assumed bearing) 765.68 feet along the South line of said Northwest quarter to a fence corner and the true point of beginning; thence North 89 degrees 08 minutes 48 seconds West 412.80 feet to a fence corner said corner being on the East right-of-way of the Monon Railroad; thence along said east right-of-way of the Monon Railroad North 0 degrees 33 minutes 06 seconds East 1067.94 feet to a fence corner; thence South 87 degrees 42 minutes 09 seconds East 406.06 feet to a fence corner; thence South 0 degrees 10 minutes 37 seconds West 1057.77 feet to the true point of beginning, containing 9.99 acres, more or less.

EXCEPTING THEREFROM a part of the West half of the Northwest quarter of Section 16, Township 8 North Range 1 West, Monroe County, Indiana, more particularly described as follows:

Commencing at the Southeast corner of said West half of the Northwest quarter in the center of the highway known as State Road #37, thence North 89 degrees 33 minutes 10 seconds West (assumed bearing) 765.68 feet along the South line of said Northwest quarter to a fence corner, thence North 0 degrees 10 minutes 37 seconds East along an existing fence 814.77 feet to the true point of beginning, thence North 87 degrees 42 minutes 09 seconds West 60.00 feet; thence North 0 degrees 10 minutes 37 seconds East 243.00 feet; thence South 87 degrees 42 minutes 09 seconds East 60.00 feet to a fence corner, thence South 0 degrees 10 minutes 37 seconds West along an existing fence 243.00 feet to the true point of beginning, containing 0.33 acres, more or less.

Section 2. BE IT FURTHER ORDAINED, that the boundaries of the City of Bloomington shall be and the same are hereby declared to be extended so as to include all of the real estate herein above described as a part of the city of Bloomington, Indiana.

Section 3. This ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.

Passed and adopted by the Common Council of the City of Bloomington, Indiana on the second day of February, 1967.


