## ORDINANCE NO. 67-26

An ordinance concerning the annexation of adjacent and contiguous territory.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

Section 1. That the following described territory be, and the same  $\overline{is}$ , hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

A part of the Northwest quarter of Section 11, Township 8 North, Range 1 West, Monroe County, Indiana, described as follows:

Beginning at a point that is 925.00 feet East of the Northwest corner of the said Northwest quarter, thence South 88 degrees 44 minutes 30 seconds East for 181.61 feet, thence South 1 degree 21 minutes 30 seconds East for 564.24 feet, thence South 88 degrees 44 minutes 30 seconds East for 193.00, thence South 1 degree 21 minutes 30 seconds East for 563.40 feet, thence South 85 degrees 45 minutes 30 seconds West for 384.30 feet, thence South 1 degree 21 minutes 30 seconds East for 30.00 feet, thence South 85 degrees 45 minutes 30 seconds West for 729.05 feet, thence North 18 degrees 45 minutes 30 seconds East for 254.85 feet, thence North 12 degrees 32 minutes East 493.91 feet, thence South 89 degrees 17 minutes 20 seconds East for 524.90 feet, thence North 0 degrees 06 minutes East for 531.42 feet and to the point of beginning. Containing in all 15.83 acres, more or less.

Section 2. BE IT FURTHER ORDAINED, that the boundaries of the City of Bloomington shall be, and the same are hereby, declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana. (Bittner Woods Subdivision)

Section 3. This ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.
