RESOLUTION 08-07

TO AUTHORIZE AGENTS TO ACCEPT PENSION LIABILITY  
ON BEHALF OF THE CITY OF BLOOMINGTON

WHEREAS, state law requires that an agent be named to accept pension liability for the City's Public Employees' Retirement Fund accounts; and

WHEREAS, the City's three accounts are the main City of Bloomington account (1116-000), the Transit account (1116-001), and the Utilities account (1116-002); and

WHEREAS, the Council desires to appoint Michael Trexler, Controller, and Daniel Grundmann, Employee Services Director, as the City's agents to accept pension liabilities in accounts 1116-000 and 1116-002; and

WHEREAS, the Council desires to appoint Christa Browning, Controller of the Bloomington Public Transit Corporation as Transit's agent to accept pension liabilities in account 1116-001;


NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

Section 1. Michael Trexler and Daniel Grundmann of the City of Bloomington are fully authorized and empowered to act on behalf of the City of Bloomington as its agents to accept pension liability for the main City of Bloomington account 1116-000 and Utilities account 1116-002, pursuant to I.C. 5-10.2-3-1, and further to execute and deliver documents related to the Public Employees' Retirement Fund of Indiana.


Section 2. Christa Browning of the Bloomington Public Transportation Corporation, is fully authorized and empowered to act on behalf of and in the name of the City of Bloomington as its agent to accept pension liability for the Transit Account 1116-001, pursuant to I.C. 5-10.2-3-1, and further to execute and deliver documents related to the Public Employees' Retirement Fund of Indiana.

Section 3. This resolution will remain in full force and effect until modified or rescinded by subsequent resolution and receipt thereof in writing by the Director of PERF.




